The National Student Nurses Association (NSNA) was established in 1952 under the guidance of the American Nurses Association (ANA) and the National League for Nursing (NLN). Membership is open to students in all nursing programs that prepare students for registered nurse licensure. This includes students preparing for an associate degree, a diploma, or a baccalaureate degree in nursing as well as students in generic masters' degree programs and doctoral programs. Registered Nurses (RNs) in BSN completion programs and pre-nursing students are also eligible for membership.

Officer Descriptions

President: The President oversees all NSSNA activities. He/She presides at board meetings. The President serves as a Nebraska delegate in the NSNA House of Delegates at the NSNA Annual Convention, which includes attending business meetings and voting for the State of Nebraska. The president is a resource person for the NSSNA officers and NSNA members across the state.

1st Vice President: The 1st Vice President assumes the duties of the President in his/her absence. He/She plans and oversees arrangements for the NSSNA's annual convention. This includes setting up committees, overseeing committee activities, and is instrumental in contacting speakers and exhibitors.

2nd Vice President: The 2nd Vice President is the chairman for the Bylaws, which includes checking with local chapters to see that their bylaws are current and in accordance with the state and national bylaws. He/She assists local chapters to bring their bylaws up to current status. The 2nd Vice President implements new resolutions passed at the NSNA Annual Convention.

Treasurer: The Treasurer plans and presents a yearly budget. They oversee dues (through reports from NSNA), but is not responsible for recruitment at this time. The Treasurer is in charge of fundraising for NSSNA.

Secretary: The Secretary records all minutes of the board meetings and at the State Convention business meetings. He/She types and submits minutes to the state office for distribution of officers and local chapters. Minutes are also sent to NSNA for monitoring state activities and are archived.

Communications Editor: The Communications Editor serves as the statewide communications chairman. He/She is responsible for updating the NSSNA web site, publishing the NSSNA newsletter, and creating the booklet for the annual convention.

Nominations Chair: The Nominations Chair encourages and recruits qualified candidates to run for state office. He/She revises candidate form and sends them to local chapters in the winter so that members can run for state office. The duties include setting up a ballot for state officer elections and considering qualifications of candidates. The chairman enforces policies regarding candidates and campaigns. He/She oversees the nomination, election and induction of officers at the state convention.

Image of Nursing: The Image of Nursing Chair's duties involve educating the public on the changing roles of a nurse. He/She encourages patients and others to speak with managers and administration when they have a negative or positive experience. He/She educated nursing students on what professionalism and positive image are and their role in the development of nursing status as a profession. The image of nursing chair encourages students to participate more in positive promotions of nursing rather than reacting to events after the fact to work with other nursing association projects in a collaborative manner.

Breakthrough: The Breakthrough Chair recruits high school students to school of nursing in Nebraska. The duties of this office include informing the high school and communications editor of the programs to be presented and the response. The Breakthrough Chair submits reports the progress and response to the state and national offices as needed.

Community Service: The Community service Chair serves as a resource for local chapters. This officer provides ideas for community service projects as well as records and sends in all statewide community service activities to the national office.

Legislative Chair: The Legislative Chair monitors major state and national legislation. He/She coordinates state legislative programs and educational activities to prepare Nebraska students to participate in the legislative process. He/She supports the NSNA positions on legislative issues. He/She acts as a liaison with legislatures, legislative organizations, government agencies, and other organizations concerned with legislature.

Student Advisor: The Student Advisor is someone who has been an active member of the previous NSSNA board. He/She consults with the current NSSNA Board, the Consultants, and nursing students requested serving as a resource person.

Parliamentary Procedure

Parliamentary Procedure is simply an organized manner of conducting a meeting. To be effective, it is important that those using the procedure are familiar with it's fundamental rules. The use of Parliamentary procedure enables meeting to be conducted with expediency and efficiency, with as little friction as possible. It allows everyone involved in the meeting to express an opinion, make motions, and to vote.

If you wish to...

Introduce business, begin by saying: "I move to/than..."

Change of perfect the motion, begin by saying: "I move to amend the main motion by inserting or striking words...so that the motion reads..."

Postpone consideration of a motion to a certain time, begin by saying: "I move to postpone this motion until..."

Recess the meeting, begin by saying: "I move to recess for (time) and to reconvene at (time)"

Adjourn the meeting, by saying: "I move to adjourn"

Nominate an individual from the floor, begin by saying: "Your name, school, Madam President, I nominate...for the position of..."

To limit the question to a certain time or number of members to discuss the topic, begin by saying: "I move to limit the question to..."

All individuals who introduce themselves or become active in business of NSSNA shall stand; state their name and school then present their business orally and in written form for the purpose of keeping the minutes of the meeting.

Interested in Running for a State Board Position?

Individuals elected into office for the NSSNA at the state convention shall serve as officers-elect until officially taking office on the week prior to the National

Student Nurses Association convention. The term of office for the NSSNA officers shall be one week prior to the NSNA convention to one week prior to the NSSNA convention the following year. Guidelines for running for a board position:

- Students must be members of NSNA to run for office.
- You cannot hold a local office while concurrently holding an office on the state board.
- ❖ You must be able to serve at least ¾ of a term before graduating and be willing to complete your term after graduation.

Note: There will be a mandatory new officer meeting following the 2021 NSSNA Convention.

Douglas County Veteran Treatment Court began in late 2016

An early sign that a veteran may have unaddressed problems may be when they first break the law. Veterans Treatment Courts are hybrid Drug and Mental Health Courts that serve veterans struggling with addiction, serious mental illness and/or co-occurring disorders. They promote

sobriety, recovery, and stability through a coordinated response that involves cooperation and collaboration with the traditional partners found in Drug and Mental Health Courts, with probation officers, Judge. They must plead guilty to charge if they fail to complete the court they can go to jail or prison for failure.

I have been a "volunteer" Mentor for Douglas County Treatment Court for 4 yrs since the beginning of the court. Each veteran in the program is assigned a mentor. All mentors must be veterans. It's hard to hold the veterans accountable if you have not walked the walked. The program is up to 24 months if you do all that is requested to do all your classes, miss no drug tests, attend court and meet weekly with your mentor you could graduate in 18 months or it could go longer as long as 3 yrs.

Currently I have 4 mentees I meet with weekly with. I spend 1 hr with each one. It has its frustrations however very rewarding program.

I have had the first female veteran to graduate and 3 male veterans graduate already they have not had any more incidents with the law.

I am helping to start a women's house to help women who get out of prison/jail restart there lives over. I have been helping since the beginning of the house-this will have religion based curriculum, life skills-budgeting, job skills, mental health counseling, other training, I will be house mom during the day or do observation to watch nonverbals and verbals, writing intake form. I will work with the women if they have to go to court or with their problems officers. Opportunity of a life time setting up a house, opening up one, collecting close...all that goes into it.

I am Mrs. Sarpy County hoping on 3 Apr to be crowned Mrs Nebraska. I decided I wanted to step outside my comfort zone and show women and young girls you can do anything you want. Age does not define you.

With doing this community service is a big part of being Mrs. Sarpy County to be Mrs. Nebraska. I did a toys for tots drive this year. At one of my boxes I had a huge help with two 12 yo boys who did a FB campaign collecting over 650 toys and I was able to collect 550 toys for a total of 1200 toys.

Rang bells for Salvation Army

Worked at Open Door mission serving luncg, preparing for dinner, washing dishes, making sandwiches, having fun in the kitchens 3

Had a female veteran having a tough time trying to take care of her family bought her Thanksgiving dinner and extras didn't want them not to have a big meal.

For two other Veterans the American Legion I belong to we brought baskets to them for thanksgiving to bring joy

On Christmas brought Christmas baskets to veterans with Turkeys, ham, fixings to have a great meal.

The same female vet I brought thanksgiving dinner bought the family several Christmas gift for each three of the kids and her too.

I am invoked in multiple veteran volunteer opportunities just tonight 25 Jan I was asked to help file a VA Claim

I'm helping another get the Purple Heart 💜 which was not awarded to him on active duty I love helping and working in the community.

My job includes creating a budget, filing taxes, paying bills, balancing our checkbooks, and reporting the financial status at our meetings each month. As treasurer I was also head of the Fundraising Committee. This year we raised \$2,148.50 from selling popcorn, we were able to donate this money to two healthcare related facilities that were more than deserving. I want to thank each of you who made my year serving on the board so memorable!

<u>Financial Report:</u> After transition of members our board started with \$18,087.29. As of February 3rd 2021 our board has \$20,519.45. Over the past year we have made \$1,409.00 from National dues, \$173.26 from the 2020 State Convention,

\$849.08 from the 2021 State Convention, \$2,148.50 from fundraising, \$1,998.57 from merchandise, \$5.27 from interest, and \$100.00 from donations. This year we have spent \$152.84 on taxes, \$764.85 on the 2020 State Convention, \$114.00 on Jotform, \$1,000.00 donated to Drew Charles, \$1,000 donated to Legal Aid, \$269.20 on 2021 State Convention, \$350.00 on Midyear, and \$702.01 on memberships to Zoom, Wix, and the purchase of cords for graduation.

<u>Douglas Shinner Legislative Director-</u> Hello, my name is Douglas Shinner. I have served on the NSSNA's board as the Legislative Board Director for the 2020-2021 year. This year started with Nurses Day at the Legislature in February 2020, where I had the opportunity to meet many nurses and legislators from across Nebraska who influence our profession. 

Keynote Speaker

Anne Boatright State Forensic Nurse Coordinator

Anne Boatright, MSN, RN, SANE-a, is a certified Forensic Nurse Examiner (FNE) and is currently the State Forensic Nursing Coordinator and Sexual Assault Payment Program Administrator at the Nebraska Office of the Attorney General. Anne strives to create a best practice standard in the State of Nebraska so victims of crime may receive the same care regardless of their location within the state. She previously headed up the Forensic Nurse Examiner Program at Methodist Health System in Omaha. She and other members of the team cared for victims of sexual assault, strangulation, domestic violence, and human trafficking. Anne began her work as a Sexual Assault Nurse Examiner in 2009.

Prior to her work as a SANE, Anne specialized in Emergency-Trauma Nursing in Omaha. She has also worked as a Medical Intensive Care Unit Nurse in Chicago, Illinois. Anne received her nursing degree from the College of St. Mary, and a Master of Science in Nursing-Nurse Executive from Nebraska Methodist College. Anne has provided education and training to over 5,000 staff members of law enforcement agencies, health systems, advocacy services and schools state wide. She continues to do outreach in various population groups to ensure awareness and care for victims of the aforementioned crimes. Anne worked to integrate the FNE/SANE programs and standards of care within the Nebraska Human trafficking task force to ensure that all aspects of response for victims/ survivors are covered.

In October of 2016, Anne was awarded Transformational Nursing Leader of the year through the American Nurses Credentialing Center's Magnet Nursing Conference. Anne has become a key, core member of the effort to the Nebraska Human Trafficking Task Force (NHTTF), especially regarding the health care system and professions as key components of the "Community Partners" portion of the NHTTF.
